# The Fundamentals of Parenting Coordination

A 16-hour online training program for professionals interested in parenting coordination.

**November 30 - December 3, 2020**

AFCC is pleased to introduce a new, comprehensive parenting coordination (PC) training, conducted online by a team of leading international practitioners and trainers. This 16-hour training program is based on the *2019 AFCC Guidelines for Parenting Coordination* and the *Recommendations for Comprehensive Training of Parenting Coordinators*. The program will take place in two segments per day, two hours each. Recordings of all sessions will be available for registrants.

This program will include a comprehensive overview of the PC process, including definition of the role, responsibilities, and function of the parenting coordinator; an overview of family dynamics; specific PC strategies, techniques, and interventions; implications of intimate partner violence; cultural considerations; ethical issues; and use of technology.

Participants will learn about the parenting coordinator's scope of authority, strategies to help parents improve cooperation and communication, how to help clients utilize the process, and how to effectively write recommendations or decisions.

## Learning Objectives

Participants in this training will be able to:

- Define parenting coordination and identify at least three differences between parenting coordination and other conflict resolution processes.
- Describe the multiple roles and functions of the parenting coordinator.
- Identify at least six elements of the professional services agreement/contract.
- List at least five stages of the parenting coordination process.
- Explain the impact of separation, divorce, and parental conflict on family dynamics and child well-being.
- Name the four models of coparenting and will be able to discuss how they impact children.
- List the steps for structuring the parenting coordination process.
- Discuss how to use outside experts and resources effectively and describe the PC roles and functions on the collaborative/support team.
- Apply two techniques for managing non-compliance, and two techniques for managing the impact of high conflict.
- Recognize when to decline an appointment and when to withdraw from a case.
- Identify when a parenting coordinator should move into the decision-making phase, and how to prepare and write those decisions.
- Apply procedures for initial and ongoing screening for IPV and implement appropriate safety interventions and protocols.
- Analyze the interplay between *AFCC Guidelines for Parenting Coordination* (2019), other ethical guidelines, and other professional practice guidelines.
- Explain the difference between explicit and implicit emotional, cognitive, and behavioral biases.
- Identify at least five diversity issues that affect the ability or willingness of coparents to engage in the process and two process modifications.
- Assess the benefits and risks of using technology in the parenting coordination process.

# Advanced Issues for Family Law and Dispute Resolution Professionals

*An 8-hour online training program for parenting coordinators, custody evaluators, mediators, judicial officers, and other professionals who work with high-conflict families.*

**December 7-8, 2020**

This program addresses the challenges often associated with the most intractable family disputes, including intimate partner violence, parent-child contact problems (including parental alienation), substance misuse, mental health disorders, and working with children in dispute resolution and evaluative processes. The program takes place in two segments per day, two hours each. Registration includes access to recordings of all training program sessions.

Presenters will examine how to address these difficult challenges, including: the dynamics of intimate partner violence in parenting time disputes; the continuum for parent-child contact problems (including affinity, alignment, realistic estrangement, and parental alienation); the effects of substance misuse and mental illness on the family system; and when and how to involve children in the dispute resolution process. Presenters will share the latest and most relevant research, while examining the many controversies related to these issues from multiple perspectives.

## Learning Objectives

Participants in this training will learn to:

- Describe the continuum of parent-child contact problems (e.g., affinity, alignment, realistic estrangement, alienation, hybrid).
- Identify at least two short-term and two long-term consequences on children involved in resist-refuse coparenting and family dynamics.
- Interface with individual and family therapist(s) concurrently involved to assist with resist-refuse family dynamics in parent-child contact problem cases.
- Explain the current research on the risks and benefits of obtaining the voice of the child.
- Identify when and how to involve children in mediation and the parenting coordination process.
- Explain best practices for interviewing children and common concerns, such as suggestibility and memory.
- Identify at least three effects of abuse, neglect, and exploitation on relationships, family dynamics, and the parenting coordination process.
- Assess when mandatory reporting of child abuse/neglect to the appropriate legal authority is appropriate.
- Identify how major mental illnesses and personality disorders affect parenting, coparenting, and the parenting coordination process.
- Identify common patterns of substance misuse and list at least three evidence-based treatments for alcohol disorder with adults.

**Debra K. Carter, PhD**, is a psychologist and parenting coordinator who has provided training across the globe. She chaired the AFCC Task Force that developed the *2019 Guidelines for Parenting Coordination*. She is the author of numerous book chapters and articles including *Parenting Coordination: A Practical Guide for Family Law Professionals*. She is also the Co-Founder and Training Director of the National Cooperative Parenting Center (NCPC) which offers services to the mental health and legal communities in North America and around the globe and is a former president of the AFCC Florida Chapter.



**Robin M. Deutsch, PhD, ABPP**, is a psychologist and former AFCC President, who served on both the first AFCC task force and the APA task force that developed *Guidelines for Parenting Coordination*. She has provided training internationally and authored chapters and articles about parenting coordination, as well as other issues related to family conflict. She was the founder and the Director of the Center of Excellence for Children, Families and the Law at the William James College where she developed the Certificate in Child and Family Forensic Issues. From 1990 until 2012 she was on the faculty of Harvard Medical School, most recently as an Associate Clinical Professor of Psychology.



**Barbara Fidler, PhD, C.Psych, Acc.FM, FDRP PC**, is a clinical developmental psychologist and has served on two AFCC task forces that developed *Guidelines for Parenting Coordination*. She has provided trainings and authored chapters and articles on parenting coordination and other areas relating to high-conflict coparenting situations. Dr. Fidler provides training to judges, lawyers, and mental health professionals and has presented at numerous conferences. She is co-author of four books and a former president of the AFCC Ontario Chapter.



**Mindy F. Mitnick, EdM, MA**, is a Licensed Psychologist specializing in complex custody evaluations and cases with child abuse allegations. She provides training on the use of expert witnesses in child abuse and divorce cases, effective interviewing techniques with children, interventions in high-conflict divorce, and the impact of psychological trauma. She served on the AFCC task force that developed the *2019 Guidelines for Parenting Coordination*, the AFCC Task Force on Guidelines for Court-Involved Therapy, and was co-chair of the Minnesota Child-Focused Parenting Time Guide Working Group. She is President Elect of AFCC.



**Matthew J. Sullivan, PhD**, has been on three AFCC Parenting Coordination task forces and is an internationally recognized author and trainer in this area of practice. He co-chaired the AFCC Task Force on Guidelines for Court-Involved Therapy and served on the American Psychological Association Ethics Committee. He was awarded the 2012 Joseph Drown award by the California Chapter of AFCC for outstanding service to children and families. He is the immediate past-president of the AFCC.

## What's Included?
